

# Pictet-Global Megatrend Selection-P USD

# IMPORTANT NOTE

- Pictet-Global Megatrend Selection (the "Fund") invests at least two-thirds of its total assets/wealth in equities or in any other security linked to equities, issued by companies throughout the world. It will be composed of a palette of securities reflecting investments in Pictet thematic open-ended investment funds, based on an equal weighting of each theme, which will normally be adjusted monthly.
- The Fund may invest up to 1/3 of its assets in structured products (such as bonds or other transferable securities whose returns are linked to the performance of an index, asset backed securities and mortgage-backed securities). Specifically, investments in assetbacked securities and mortgage-backed securities can be made up to only 20% of the total net assets of the Fund.
- The Fund may also invest in financial derivative instruments (such as credit derivative instruments on indexes) to meet its investment objective.

## INVESTMENT OBJECTIVE

The sub-fund seeks capital growth by investing at least twothirds of its total assets in corporate shares in accordance with the investments of Pictet open-ended theme funds, where each theme is, in principle, equal-weighted and rebalanced each month. The investment universe is not restricted to a specific geographical zone.
